



MEMORANDUM OF UNDERSTANDING

BETWEEN

University of Phayao (Thailand)

And

Kandatsu Resort Co., Ltd (Japan)

This Memorandum of Understanding (MoU) is established to enhance academic exchanges and other academic cooperation to benefit the University of Phayao, located at 19 Moo 2, Maeka Subdistrict, Mueang Phayao District, Phayao Province, Postal Code 56000, Thailand. Represented by Associate Professor Dr. Supakorn Pongbangpho, President of the University of Phayao, who will hereinafter be referred to as "the University of Phayao," of the first part, and Kandatsu Resort Co., Ltd located 4121-1 Kandatsu, Yuzawa, Minamiuonuma District, Niigata 949-6120, Japan. Represented by Nobuo Sugiki, Personnel and Sales Department Manager, who will hereinafter be referred to as "Kandatsu Resort Co., Ltd" The two parties hereby enter into this General Agreement to foster international cooperation:

Article 1

The two institutions will establish academic exchanges and cooperative relationships during a period of five years beginning on the date on which the responsible administrative officers of both institutions have signed this agreement. Among the kinds of cooperation identified as mutually beneficial are professional training or cooperative education.

Article 2

Both institutions should designate an office and a liaison in charge of this General Agreement. From Kandatsu Resort Co., Ltd's side, it will be Nobuo Sugiki being a liaison person. From University of Phayao's side it will be the School of Liberal Arts with the Dean of School being a liaison.

Article 3

In the event that the Memorandum of Understanding (MoU) reaches its expiration date and consequently comes to an end, but both parties wish to renew or extend the term of the MoU, both parties shall agree in writing to renew or extend the term of this MoU as appropriate, based on reasonable grounds as applicable. If either party wishes to terminate this Memorandum of Understanding, they must provide the other party with notice no less than 90 days in advance.

Article 4

This Memorandum of Understanding (MoU) is executed in four copies with identical content in Thai and English. All parties have thoroughly read and understood the terms herein and find them to be in complete accordance with their intent. As evidence thereof, the parties have affixed their signatures, along with their official seals (if applicable), in the presence of witnesses. Each party shall retain two copies in Thai and English.
